	Confirmation from the vendor that the volume and WAL entered on this application are correct and correspond to the Water Access Licence (WAL) details completed in the associated WaterNSW Form 71Q.
	WaterNSW Form $71Q$ – Application to Assign Share Component with Transferor's details completed for CICL to approve and return to the decreasing WAL to lodge $71Q$ and the Notification with Land Registry Services.
